3. All players must wear correct tennis attire, as per the Association by-law.
4. Home teams must supply TWO pairs of new tennis balls (By-law 18).
5. Singles Rubber is to be played first in Singles/Doubles Rubbers sections. For a few Senior Singles/Doubles matches, it has been agreed to play the doubles rubber first due to court availability, despite what By-law 8e states.

6. Only enter Completed Matches for Finals.
