NOTES:

1. Venue clubs are to provide two courts for each match.
2. Home teams are to provide Score Book.
3. All players must wear correct tennis attire, as per the Association by-law.
4. Home teams must supply TWO pairs of new tennis balls (By-law 18).
5. Doubles Rubber is to be played first in Singles/Doubles Rubbers sections (By-law 8[b]). If there are any queries as to how the match is to be conducted, please contact Match Convenor (Trevor Smyth) on 0468 958 927.

6. A reminder that all Senior presentations are to be made at Doveton after matches completed.

All teams must use a scoresheet and enter all players names FOR ALL RUBBERS prior to the start of match and bring it with you to the presentations where scores will be entered on Club Zone.

All clubs are expected to have at least one player or club official attend the presentation afternoon to collect their trophies and/or pennant. If a club is unable to attend, it would be appreciated if a courtesy call, or text, is made to our Match Convenor as soon as possible after the completion of the match.

7. Only enter Completed Matches for Finals. In the event of rain, all teams are expected to make reasonable efforts to start and complete matches.
